Do not call or go to the Municipal Court before first reading these instructions. Take this notice with you if you consult an attorney.

You must respond to your citation prior to your court date by pleading guilty and paying the fine at least 24 hours prior to your court date or by appearing in court on your court date. Failure to pay or appear at your court date could result in a fine up to \$500.00, ninety days in jail, and could also lead to suspension of your driver's license and a warrant for your arrest.

To plead guilty and pay your fine; Sign the back of the citation and return it along with a check or money order (in US dollars) for the full amount due payable to "Warrenton Municipal Court". Write the citation number and daytime phone number on the front of the check/money order and mail it to the address at the top of this page. See list for fine amounts and more information.

For any offense not listed below, you must appear in court. For any offense involving a motor vehicle accident, property damage, or injury to any person, you must appear in court. Please call the Warrenton Municipal Division at (636)456-3535 if you have any questions.
