SECTION 210.710: FIREWORKS – SALE OR USE PROHIBITED.

Except as provided for herein, it shall be unlawful within the city of Warrenton for any person, firm or corporation to sell, offer for sale, expose for sale, use, discharge or explode any fireworks as defined in Section 320.106, RSMo.

SECTION 210.720. FIREWORKS – EXHIBITION PERMIT

No fireworks exhibitions shall be held within the corporate limits of the City without first obtaining a permit from the Board of Aldermen. Permits will be subject to the Board approved policy. The fee for a permit for each fireworks exhibition shall be thirty-five (\$35.00) dollars.

Note: A permit is also required by the Warrenton Fire Protection District (636-456-8935) which includes an inspection prior to the fireworks exhibition and proof of licenses from the operator and manufacturer.
